

## Q1 Where do you live?






## Q2 What is your age bracket?





# Q7 Would you utilize the option of paying for local services including taxes, utilities, facility rentals, programs or other charges by credit card if it included a 2% surcharge?





## Q8 How satisfied are you with the quantity of information received from the Township (i.e newsletters, Facebook, website)?





# Q9 Would you support an increase in spending on communication (i.e more info in the local paper, more frequent newsletters)?





#### **Summary of Comments & Suggestions**

With a variety of suggestions offered in the survey responses, staff grouped like items together so that council can get an overall picture of where residents would like to see focus during the 2022 budget deliberations.

**General Government**: Economic Development (11), Taxes (9), Greenspace (5), By-law enforcement (4), Communications (3), Parking (2), Green infrastructure (2)

**Public Works:** Green bins spring through fall (5), Winter maintenance concerns (5), Sidewalk improvements (5), Large item/recycling depot (4), Rural road maintenance (4), water fees (4), sweep streets more (3), sewers in Granton park (3), WWTP expansion (2)

**Parks & Recreation**: Update/increase sports amenities (11), Expanded program offerings (10), Walking trails (8), Playgrounds in Clandeboye/new subdivisions (7), indoor pool (3), dog park (3), Tree planting (2).

Fire Services: Expand service (# volunteers, etc) (3)

Comments that were outside of municipal scope or political in nature were not included in summary survey findings. Staffing considerations should not be considered in a public forum and were also excluded from the summary.
